

## **NOTICE OF PUBLIC HEARING (ELECTRONIC MEETING)**

**REQUEST:** 

To hear public comment in regards to Zoning Text and Zoning Map amendments to the Vineyard Zoning Ordinance, Special Purpose District Title 3 (Town Center Form-Based Code). The property consists of approximately 345 acres of land bounded by the Utah Provo Main Rail Line on the east, Utah Lake Shoreline to the west, Vineyard Connector and 400 North to the south and 1600 North on the north. The proposed zoning text amendment will affect standards pertaining to all land within the Town Center District. The amendments, among others, include adopting a new district map, open space requirements, alignment and design of the Lake Promenade, parking requirements, residential amenities, allowable uses, building standards and design, landscaping & maintenance requirements, and road sections & layout. The proposed zoning map amendment will affect the following parcels identified with serial numbers: 17:026:0045 (253.7 acres), 40:455:0079 (32.1 acres), 17:024:0002 (4.5 acres) and 17:024:0001 (2.3 acres). The zoning map amendment will not affect the Lakeside Residential District (Also known as, Lake Front at Town Center Development).

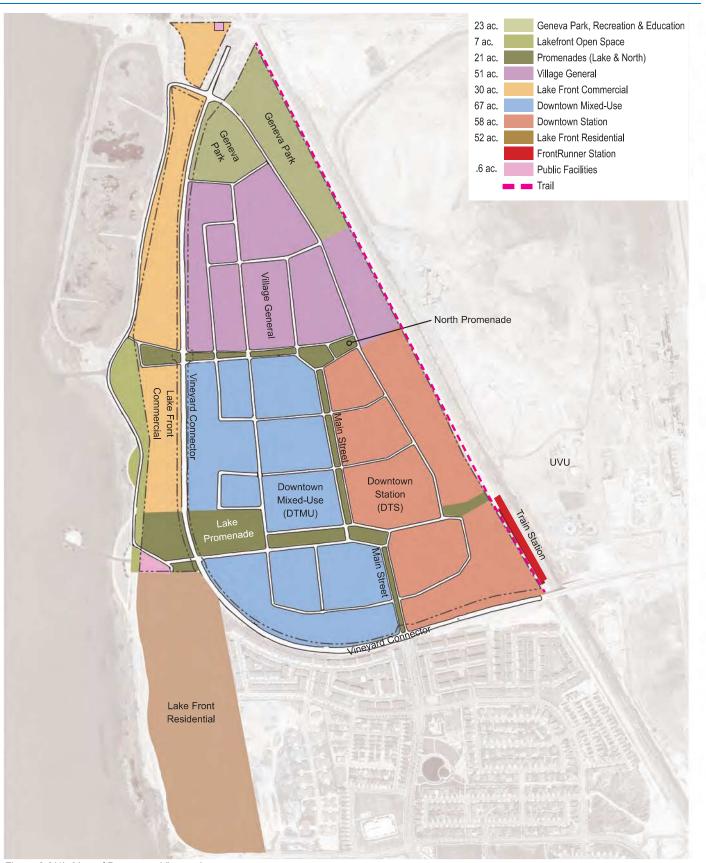


Figure 2.0(1). Map of Downtown Vineyard.
