I further declare and certify that the Towing Business will comply with Vineyard Municipal Code Chapter 5.18 Towing License and Section 10.04.060 Towing Regulations by performing non-consensual towing or parking enforcement operations only:

1. After receiving a written or telephonic request from the owner of the property where the vehicle is located, or the duly-authorized agent of the owner, or
2. On a property where the property owner and the Towing Business have entered into, and are in compliance with, a contract that meets all the requirements of Vineyard City Code Section 10.04.060.

I understand and agree that prior to conducting any towing or parking enforcement operations on a property for which this Towing Business has entered into a contract as described above, the Towing Business must provide to Vineyard City a copy of the contract and any additional evidence necessary to show compliance with the contract and the provisions of Vineyard Municipal Code. I request that Vineyard City treat the documents I submit in conjunction with this application with business confidentiality and classify them as protected records under applicable government records access and management laws because these documents contain proprietary information regarding my business dealings with property owners.

I declare under penalty of perjury that I am the owner or authorized agent for the Towing Business that is the subject of this application and that statements, answers, and documents submitted in connection with this application are true and correct to the best of my knowledge.

- Evidence of surety bond and property damage insurance required by Subsections 7 and 8 of Vineyard Municipal Code Section 5.18.030
